## TRAVEL AFFIDAVIT

I understand that, under current United States restrictions on travel to Cuba, travel-related transactions are prohibited except for the following categories. By signing my name at the bottom of this affidavit, I am declaring that I fall under the category I have checked below. I understand that I am required to keep a complete and accurate record of my Cuba travel-related transactions for five years after the travel is completed, including proof that my travel qualifies under the category I have checked above.

Please retain this affidavit for your personal records and the day of travel to Cuba, in case you are asked for it. Please print this affidavit, fill it out with your personal details and sign it. Thank you.

## **General Licenses** Visiting Close Relative in Cuba (§ 515.339). I am traveling to visit a close relative in Educational Activities (§ 515.565). I am a faculty member, staff person, or Cuba, who is either (a) a Cuban national, or (b) a U.S. Government employee assigned to student of an accredited U.S. graduate or undergraduate degree-granting academic the U.S. Interests Section in Havana. This relative is related to me by blood, marriage, or institution (the "University"). My travel is for one of the following purposes: (a) adoption and is no more than three generations from me or from a common ancestor. participation in a structured educational program in Cuba as part of a course offered for credit by the University, (b) non-commercial academic research in Cuba Accompanying Family Member on Visit to Close Relative in Cuba (§ 515.561). specifically related to Cuba and for the purpose of obtaining a graduate degree, (c) I share a common dwelling as a family with another person who is subject to U.S. participation in a formal course of study at a Cuban academic institution, which will jurisdiction and is traveling to Cuba. That traveler is visiting a Cuban national or a be accepted for credit toward a graduate or undergraduate degree, (d) teaching at a Cuban academic institution for no less than 10 weeks, and I am regularly employed U.S. Government employee as described in item 1 above. I am accompanying that traveler on a family visit that is covered by item 1. in a teaching capacity at the University, or (e) organization of and preparation for any of the educational activities authorized Government or Intergovernmental Organization Employee on Official Business by (a) through (d). I have a letter on University letterhead, signed by the University's (§ 515.562). I am a U.S. or foreign government official or a representative of an designated representative, confirming that I meet the requirements of this paragraph. intergovernmental organization of which the United States is a member. I am I understand that I am required to carry the letter with me when I travel to Cuba. traveling on official business of my government or international organization. Religious Activities (§ 515.566). I am a member or a staff person of a religious Journalistic Activities (§ 515.563). I am regularly employed as a journalist by a organization located in the Untied States. My travel is for the purpose of participation news reporting organization, or I am regularly employed as supporting broadcast or in a full-time program of religious activities while in Cuba. I have a letter on technical personnel, and I am traveling to Cuba to engage in journalistic activities. the religious organization's letterhead, signed by the organization's designated I understand that I may be required to comply with U.S. Commerce Department representative, confirming that I am a member or staff of the organization and export licensing requirements if I am exporting equipment or other items to Cuba. am traveling to Cuba to engage in religious activities under the auspices of the organization. I understand that I am required to carry the letter with me when I Professional Research (§ 515.564). I am a full-time professional whose travel to Cuba is travel to Cuba. directly related to non-commercial, academic research in my full-time professional area.
